I did this more than 5 times but less than 10, I may have done this over the past three months. For about the last four months or so I have been taking lottery tickets with out paying for them. Today May 18, 2004 at about 6:15 AM I did log into the lottery machine and did take \$189 worth of lottery tickets without paying.
